General Terms and Conditions

- **1.** <u>Event:</u> First Attack 2025 is the largest competitive video game tournament in the Caribbean, organized by E-Sports Red Rooster, <u>L</u>LC (Organizers).
- 2. <u>Date and place of the Event:</u> The event will be held from Saturday, October 25th to Sunday, October 26th, 2025, at the Puerto Rico Convention Center.
- **3.** Merchant Registration: All merchants must be registered in the Merchant Registry of the Puerto Rico Department of Treasury or United States to participate in the event. Merchants must have their Merchant/Exhibitor Registration Certificate available at their exhibition space in case of inspection by the Treasury Department. Each Merchant will be responsible for collecting the corresponding taxes according to the laws of the Government of Puerto Rico. Each Merchant will be responsible for any fines that may be imposed by the corresponding government agencies in case of non-compliance with existing government regulations.
- **4.** <u>Right of Admission:</u> The Organizers reserve the right to admission to the event for Exhibitors, their assistants, and participants. Similarly, the Organizers reserve the right to expel from the event any Exhibitor, assistant, or participant who fails to comply with this Exhibitors Regulation.
- **5.** <u>Payment Dates:</u> The deadline to pay the total amount for your exhibition space is October 1st, 2025. Payments will not be accepted on the day of the event unless pre-arranged.
- **6.** Payment Methods: Payments can be made via:
 - a. Cash: You can call 787-510-5260, and we will arrange a meeting point.

 - **c.** <u>PayPal:</u> Payments can be sent to <u>redrooster2019a@gmail.com</u>, providing your group information or reservation name.
 - d. ATH Mobile: Send to Business RedRooster.
- **7.** Exhibition Space Reservation: Exhibition spaces will be considered reserved only for those who have paid in full. Each exhibition space is designated with the name of its group or reservation name.
- **8.** <u>Setup and Takedown:</u> Exhibitors will have from 12 pm to 8 pm on Friday, October 24, for the setup of their exhibition space and Sunday, October 26, from 10 pm to 11 pm for teardown (subject to changes, you will be notified). Set-up will not be accepted outside of the established schedule.
- 9. <u>Electricity:</u> This cost is included starting with **5 AMPS** and must be notified in advance as it needs to be coordinated with the Convention Center. Each Exhibitor must bring their own extension cords and multiplugs to connect to the existing outlets. If the exhibitor wishes to add additional AMPS to their area, this cost will be separate and must be coordinated directly with Esquilin Events Service, Inc. The Organizers are not responsible for damage to electronic equipment caused by voltage fluctuations during the event.
- **10.** <u>Sale of Items by Clubs:</u> Sellers will be able to sell provided they comply with Puerto Rico laws and the following section.
- 11. <u>Theft and Losses:</u> The Organizers are not responsible for lost or damaged items if the Exhibitor decides to leave their merchandise at the event location during the event's recess hours or after the activity ends.
- **12.** <u>Profits and Sales:</u> All profits from sales are one hundred percent (100%) of the Exhibitor's. The Organizers do not guarantee a minimum sales volume and are not responsible for any financial losses to the businesses.
- **13.** <u>Sales Claims:</u> Sales transactions will be exclusively between the Exhibitors and the visitors to the event. The Organizers are not responsible and will not intervene in sales claims and/or negotiations between businesses and event visitors.

- **14.** <u>Sales and Promotion Outside Assigned Exhibition Spaces:</u> The sale and promotion of items and businesses are prohibited around the event location (parking lots, etc.). They can only sell and promote items within their designated exhibition space.
- **15.** <u>Sale of Adult Material:</u> Completely prohibited. We define adult material as anything explicit, sexually charged, not suitable for children, and/or with obscene language. The display, sale, and distribution of such material are not allowed at the event.
- **16.** <u>Sale of Metal Weapons:</u> The sale of metal weapons will be allowed if they are not sharpened, are sealed in their box at the time of transaction, and their sale is restricted to people over 18 years old.
- 17. <u>Sale of Food:</u> Vendors intending to sell food at the event will have an additional fee imposed by the convention center since they would have to acquire an Opt-Out. *All agreements must be managed through the Convention Center*.
- **18.** Sale of CDs, Movies, and Other Pirated Material: The sale of CDs, movies, TV series, or other pirated or unauthorized items is prohibited. Every disc sold at the event must be in its original box, not in paper sleeves or semi-transparent plastic boxes (jewel cases). The Organizers will not assume any responsibility for pirated items sold during the event.
- **19.** <u>Audio and/or Video in Exhibition Spaces:</u> Moderate use of audio and video equipment is allowed in exhibition spaces if its use does not disrupt activities in other exhibition spaces or at the event and does not contain adult material.
- **20.** <u>Behavior of Exhibitors:</u> Any act of harassment, aggression, or improper conduct by any merchant, their assistants, or club members may lead to their immediate expulsion from the event. They will not receive a refund for their exhibition space, and they will face charges according to the Puerto Rico Police and at the discretion of the Organizers.
- **21.** Photography and Videos: The Organizers reserve the right to take photos and/or videos of participants and exhibition spaces assigned to Exhibitors for advertising purposes.
- **22.** <u>Garbage in Exhibition Spaces:</u> Exhibitors must always keep their exhibition spaces clean and dispose of garbage daily during the event.
- 23. <u>Event Postponement:</u> If due to factors beyond the Organizers' control, the activity is postponed to a new date more than 45 days after the date specified in the Exhibition Space Application, the Exhibitor will have the option to claim the exhibition space cost or continue with it. If the new date is less than 45 days after the date specified in the Exhibition Space Application, the Organizers will not return the money. Contracts signed based on the original date of the activity will be considered valid.
- **24.** Event Cancellation: The Organizers commit to refunding Exhibitors the payment for exhibition spaces if, due to weather or other factors beyond the Organizers' control, the event is canceled. The payment will be made no later than sixty (60) days after the cancellation announcement by the Organizers.
- **25.** <u>Right to Changes:</u> The Organizers reserve the right to partially or fully modify or annul this regulation to ensure the best possible information and adapt to new situations.
